The following terms and conditions apply to all of the above fees and tariffs:

1. The fee rate as set out above is calculated as the percentage of the value in EUR of the applicable transaction. Vivid will inform you about the applicable fees before and after your order is executed.
2. The fee rate as set out above is calculated on a monthly basis. Your first monthly period starts at the date of opening of your Crypto Pocket. In other words, if you open your Crypto Pocket e.g. on the 15th of a month, your monthly period will renew on the 15th day of each subsequent month.

3. The fee rate for your first monthly period will be the fee rate of a monthly turnover of less than €5,000. Hereafter, the applicable fee rate applicable for the next monthly period will be calculated based on the turnover value of the previous monthly period in accordance with the transaction value thresholds as set out in the left column above. This fee rate will be calculated and applied automatically for your next monthly period.
4. Your monthly turnover is calculated as (i) the EUR sum of all crypto buy and sale transactions and (ii) the EUR sum of all crypto swap transactions, for each monthly period respectively.
