

Vivid Money Program - Invest Giveaway

IMPORTANT: This is a prize draw. There is no guarantee of winning a prize.

Prerequisites:

- Every existing private customer of Vivid Money who holds an active account with Vivid Money ("**Eligible Customer**") for the full Program period is entitled to participate in the Vivid Invest Giveaway Program – Competition EU-wide ("**Program**").
- In order to participate in the Program, the Eligible Customer must:
 - comment on the specific Instagram post, share their personal Vivid referral link and tag 2 Instagram users **or**
 - retweet the specific Twitter post with their personal Vivid referral link.
- Vivid Money will select winners on Instagram and Twitter on the 29th of June 2021. The winners will be chosen randomly.
- By participating, the Eligible Customer gives Vivid Money permission to contact him/her by private message on Twitter and Instagram if the Eligible Customer has won.
- Participation in the Program is free of charge.
- Signing up for a Vivid Prime account will not increase the Eligible Customer's chance of winning.

Eligibility for Participation:

- The Eligible Customer must be of legal age (18 years or older) and must be a resident of one of the following countries: Germany, France, Spain, Ireland, Slovakia, Greece, Belgium, Estonia, Finland, Luxembourg, the Netherlands, Portugal, and Slovenia.
- Employees of Vivid Money are excluded from participating in the Program.
- The Eligible Customer may win only once. Commenting and/or re-tweeting more than once during the Program will not increase the Eligible Customer's chance of winning.
- Participation will only be counted on **one** social media platform, either Instagram or Twitter. Multiple entries will not be counted wither.

Program period:
